## **CONSENT ORDER**

The Louisiana Professional Engineering and Land Surveying Board [hereinafter the "Board"], by and through its Executive Director, pursuant to authorization by the Board, and James V. Reuter, III, P.E. [hereinafter "Respondent"] hereby agree to the following:

At all times material hereto, Respondent was a licensed in the State of Louisiana as a professional engineer, number PE-20137. At all times material hereto, Albert Architecture & Urban Design, APLLC [hereinafter "Albert Architecture"] was not licensed in the State of Louisiana as a professional engineering firm and, therefore, was not authorized to practice and/or offer to practice engineering in the State of Louisiana. Albert Architecture subsequently became licensed in the State of Louisiana as a professional engineering firm, number EF-6992, effective January 6, 2021. From November 19, 2018 to September 3, 2019 Respondent was an employee and representative of Albert Architecture.

An investigation was opened based upon the Board's receipt of information and/or documents which suggested that Respondent may have committed violations of the Board's laws and/or rules. The investigation disclosed that (a) between November 19, 2018 and September 3, 2019 Albert Architecture admittedly offered to provide engineering services in Louisiana and provided engineering services on at least nine (9) projects in Louisiana and (b) Respondent provided engineering services for Albert Architecture in Louisiana in connection with said projects.

La. R.S. 37:681 and La. R.S. 37:700(A)(1) and (9), to wit LAC Title 46:LXI§2301(B), prohibit the practicing of and/or offering to practice engineering without proper licensure. La. R.S. 37:698(A)(12) prohibits licensees from aiding or assisting another person in violating the

laws and/or rules of the Board. La. R.S. 37:698(H) permits the Board to take disciplinary action against persons who violate La. R.S. 37:698(A)(12), upon a finding of guilt following the preferral of charges, notice and hearing and a majority vote of its entire membership authorized to participate in the proceeding. La. R.S. 37:681, La. R.S. 37:698(A)(12), La. R.S. 37:698(H), La. R.S. 37:700(A)(1) and (9), and LAC Title 46:LXI§2301(B) were in effect at all times material hereto.

It is undisputed that (a) at all times material hereto Respondent was licensed in Louisiana as a professional engineer, (b) prior to January 6, 2021 Albert Architecture was not licensed in Louisiana as a professional engineering firm and, therefore, was not authorized to practice and/or offer to practice engineering in Louisiana, (c) from November 19, 2018 to September 3, 2019 Respondent was an employee and representative of Albert Architecture, (d) between November 19, 2018 and September 3, 2019 Albert Architecture admittedly practiced and offered to practice engineering in Louisiana without proper licensure and (e) Respondent aided or assisted Albert Architecture in violating the laws and/or rules of the Board.

By letter dated May 16, 2022, the Board gave notice to Respondent that it was considering the preferral of charges against Respondent on the grounds that Respondent may have violated La. R.S. 37:698(A)(12), relative to aiding or assisting another person in violating the laws and/or rules of the Board.

Wishing to dispense with the need for further disciplinary action and to conclude the instant proceeding without further delay and expense, for the purpose of this proceeding only, Respondent and the Board do hereby enter into this Consent Order, in which Respondent of his own free will consents to the issuance of a Consent Order by the Board, wherein Respondent agrees to (a) pay a fine of Five Hundred and No/100 (\$500.00) Dollars, (b) pay administrative costs of Two Hundred Ninety-six and 97/100 (\$296.97) Dollars, (c) successfully complete the Board's online Louisiana Laws and Rules Quiz, (d) successfully complete the Board's online Louisiana Professionalism and Ethics Quiz, (e) the immediate suspension of his Louisiana professional engineer license if he fails to comply with any portion of this Consent Order, with said suspension continuing until he so complies and (f) the publication of this Consent Order on the Board's website and a summary of this matter in the Board's official journal, the *Louisiana* 

Engineer and Surveyor Journal, and the reporting of this matter to the National Council of Examiners for Engineering and Surveying (NCEES), identifying Respondent by name.

Respondent admits that his conduct as set forth above constitutes violations of the above referenced laws and/or rules as stated herein. Respondent acknowledges awareness of said laws and/or rules and states that he will comply with all applicable laws and rules henceforth.

Respondent has been advised of his right to an informal conference, to be represented by counsel before the Board and/or to appear at any hearing personally or by counsel and present witnesses and evidence in his own behalf, he hereby waives this right and his right to appeal, and he states affirmatively that he has been afforded all administrative remedies due him under the law.

Respondent further acknowledges awareness of the fact that the signed original of this Consent Order will remain in the custody of the Board as a public record and will be made available for public inspection and copying upon request.

Therefore, in consideration of the foregoing and by signing this Consent Order,
Respondent does hereby waive his right to an informal conference, to a hearing before the Board,
to the presenting of evidence and witnesses on his behalf, to Findings of Fact and Conclusions of
Law in this case, and to judicial review of this Consent Order.

Respondent hereby represents that (a) he fully understands the meaning and intent of this Consent Order, including but not limited to its final and binding effect, (b) he has voluntarily entered into this Consent Order and that no other promise or agreement of any kind has been made to or with him by any person whatsoever to cause the execution of this instrument and (c) the sanctions set forth in this Consent Order do not prevent the Board from taking further disciplinary or enforcement action against Respondent on matters not specifically addressed in this Consent Order.

WHEREFORE, the Louisiana Professional Engineering and Land Surveying Board and Respondent agree that:

1. Respondent shall pay a fine of Five Hundred and No/100 (\$500.00) Dollars, which shall be tendered to the Board by certified check payable to the Board, due upon the signing of this Consent Order; and

2. Respondent shall pay administrative costs of Two Hundred Ninety-six and 97/100

(\$296.97) Dollars, which shall be tendered to the Board by certified check payable to the Board,

due upon the signing of this Consent Order; and

Respondent shall successfully complete the Board's online Louisiana Laws and 3.

Rules Quiz with a score of 90% or higher and return it to the Board within sixty (60) days of the

effective date of this Consent Order; and

4. Respondent shall successfully complete the Board's online Louisiana

Professionalism and Ethics Quiz with a score of 90% or higher and return it to the Board within

sixty (60) days of the effective date of this Consent Order; and

Respondent's Louisiana professional engineer license, number PE-20137, shall be

immediately suspended if he fails to comply with any portion of this Consent Order, with said

suspension continuing until he so complies; and

This Consent Order shall be published on the Board's website and a summary of

this matter shall be printed in the official journal of the Board, the Louisiana Engineer and

Surveyor Journal, and reported to the National Council of Examiners for Engineering and

Surveying (NCEES), identifying Respondent by name; and

This Consent Order shall not become effective unless and until it is accepted and

signed by and on behalf of the Board. Should the Board not accept and sign this Consent Order,

it is agreed that presentation of this matter to the Board shall not prejudice the Board or any of its

members, staff, attorneys or representatives from further participation, consideration, or

resolution of any further proceedings herein.
