## Message from the Chairman

#### Charles G. Coyle, III, PLS

2020. What a year! It seems like a decade ago that LSU was playing for the National Championship in front of a capacity crowd at the Superdome. Since then, we have experienced a global pandemic that shuttered the economy, homeschooling our children (*Gulp!*), the closing of bars (*double Gulp!*), two hurricanes that cut through the heart of our state and, if that weren't enough, a presidential election. We have also experienced a cycle of license renewals under our new Continuing Professional Development (CPD) rules. The staff and many of the board members have taken numerous calls and lots of questions from licensees about the new process for tracking CPDs. To assist, we thought it wise to go over the new rules once more.

The new rules are as follows:

- **Professional Land Surveyors** are required to obtain 8 Professional Development Hours (PDHs) per calendar year. At least 1 PDH per calendar year shall be in professional ethics, and at least 1 PDH per calendar year shall be in standards of practice for boundary surveys in Louisiana.
- **Professional Engineers** are required to obtain 15 PDHs per calendar year. Note that no more than 8 PDHs may be obtained in a single calendar day. At least 1 PDH per calendar year shall be in professional ethics for all professional engineers. For professional engineers who design buildings and/or building systems, at least 4 PDHs per calendar year shall be in Life Safety Code, building codes and/or Americans with Disabilities Act Accessibility Guidelines.
- **Dual Licensees** are required to obtain 15 PDHs per calendar year. At least one-third (or 5 PDHs) shall be engineering related and at least one-third (or 5 PDHs) shall be surveying related, with the remaining one-third in either engineering or surveying. At least 1 PDH per calendar year shall be in professional ethics, and at least 1 PDH per calendar year shall be in standards of practice for boundary surveys in Louisiana. Also, for professional engineers who design buildings and/or building systems, at least 4 PDHs per calendar year shall be in Life Safety Code, building codes and/or Americans with Disabilities Act Accessibility Guidelines.

The new rule for Excess PDHs is that you can carry over a maximum of 7 PDHs into the subsequent calendar year. You can refer to Chapter 31 of the Rules of the Board for further information and explanation on CPD. The Rules are available at the LAPELS Board website, <u>www.lapels.com/LawsRules</u>.

So, what does this mean if you have a renewal coming up? Here are some scenarios:

Scenario No. 1 – Your renewal is in either March or September of 2021.

You must show that you have obtained 8 or 15 PDHs, as stated above, in calendar year 2019 and 8 or 15 PDHs in calendar year 2020.

Scenario No. 2 – Your renewal is in either March or September of 2022.

You must show that you have obtained 8 or 15 PDHs, as stated above, in calendar year 2020 and 8 or 15 PDHs in calendar year 2021.

If you see the pattern, you'll notice that you simply must show that you ob-

tained the required number of PDHs within each of the two calendar years prior to the year of your renewal, regardless if your renewal is in March or September. Remember, you can carry over a maximum of 7 hours each year. For example, if a surveyor attended the 2019 LSPS Convention and obtained 15 hours, 8 of those can count for 2019 and 7 hours could count for 2020. You would only need 1 more PDH in 2020 to have all the hours you need for your 2021 renewal. If an engineer attended an 8-hour class in Life Safety Code in 2019, 4 of those hours could count for calendar year 2019 and 4 can be carried over for calendar year 2020. Keep in mind, those would be 4 of your maximum of 7 carryover hours.

You can earn PDHs in Professional Ethics, Board Laws and Rules, and Louisiana Standards of Practice by taking the LA-PELS online exams, free of charge. Visit <u>www.lapels.com</u> and click on "Online Quizzes" at the top of the page.

Also, those of you who have retired from working or are no longer actively working in surveying or engineering and wish to keep your license in an 'active' status, are required to obtain the requisite hours for your renewal cycle. If once you retire or stop working and are not practicing surveying or engineering nor are you wanting to obtain the requisite CPD hours, you should request to go to an 'inactive' or 'retired' status. A license in 'active' status is subject to audit to ensure you are obtaining the requisite CPD hours.

Due to the cancelling of many conventions and meetings because of the COVID-19 pandemic, the board has adopted special exceptions for calendar year 2020. The deadline for obtaining CPD hours for calendar year 2020 is extended until April 30, 2021. Please note that if you obtain CPD hours between January 1, 2021 and April 30, 2021 and intend to use those hours to fulfill the requirement for calendar year 2020, those hours cannot be counted toward requirements for calendar year 2021. In other words, no double-counting of CPD hours obtained between January 1 and April 30, 2021.

As always, the staff is available to answer any questions you may have regarding CPD compliance.

As we close this year, we say goodbye to two board members, Alan Krouse, P.E. and Scott Phillips, P.E., P.L.S. We appreciate their diligence and dedication during their six year term, which was extended a few months due to the pandemic. We welcome our new board members, Linda H. Bergeron, P.E. and Byron Racca, P.E., and look forward to working with them.

As the holiday season approaches, I wish you all much cheer and a prosperous new year in 2021. Let's get 2020 behind us. We have nowhere to go but up!





## Capitol View: from Haynie and Associates

The Legislature adjourned and headed home on June 30th knowing that there was a strong chance that they would be back in their 3rd session of 2020 before the end of the year. Sure enough, with little warning, the Legislature called themselves into a special session which started September 28th and runs through October 27th. The main focus of the "Second Extraordinary Session" has been to address issues arising from Hurricanes Laura and Delta as well as the continued response and budget ramifications of COVID 19. The most high profile has been an effort by the most conservative members of the House Republicans to upend the Governor's authority to put in place COVID 19 restrictions such as limiting business and personal freedoms.

Included in the Special Session's call, with special thanks to Senator Hewitt, was language allowing for the legislature to address the engineering licensing changes which we intended to offer during the regular 2020 session in March before COVID 19 caused the legislature to recess and not take up our legislation. Filed during the special session as SB 17, the legislation removes old provisions and modernized terminologies in the engineering licensing law and most substantively allows for an exception to the passage of the FE exam for qualified individuals with at least 20 years of experience.

A special thank you to Senator Sharon Hewitt and Representative Foy Gadberry for their masterful sponsoring of SB 17. The legislation passed through the process in nearrecord time, unanimously passing all 4 steps of the legislative process in roughly a week.

I am happy to report that on October 16th Governor John Bel Edwards signed SB 17 into law and it now becomes ACT 2 of the 2020 Second Extraordinary Session, which will go into effect on January 1st, 2021.

As the Special Session comes to an end, attention will move to the 2021 Fiscal session which is set to convene on April 12th, 2021, and adjourn by June 10th, 2021.

That session is "fiscal" meaning that general subject matter bills will be limited and legislation that deals with taxation and revenue will be allowed. For example, we anticipate an organized push to raise infrastructure revenue through either a fuel tax or another mechanism. If Congress passes another round of stimulus funding (CARES ACT), the legislature may meet again in late 2020 or early 2021.

As you are undoubtedly aware, Presidential Election Day is November 3rd, PLEASE VOTE!




