- 13 2. Costs of \$1,014.57
- 14 3. Publication on the Board’s website and in the Journal with name
- 15 4. Report to NCEES with name

47 903, 909, 2503 and 2701 as follows:

49 **§903. Professional Engineer Licensure**

50 A. – E.2. ...

51 F. The requirements for licensure as a professional engineer under the  
52 alternative provided in R.S. 37:51 et seq. are as follows:

- 53 1. the applicant for licensure as a professional engineer shall be an  
54 individual who holds a current and valid license to engage in the practice of  
55 engineering issued to him/her by proper authority of a state, territory, or  
56 possession of the United States, or the District of Columbia, who has held such  
57 license for at least one year, who has passed any examinations or met any  
58 education, training, or experience standards as required by such other  
59 jurisdiction, who is held in good standing by such other jurisdiction, who does  
60 not have a disqualifying criminal record as determined by the board under the  
61 laws of this state, who does not have a disciplinary action or investigation  
62 pending in another state, territory, or possession of the United States, or the  
63 District of Columbia, who lives in this state and has provided proof of residency,  
64 who has submitted an application for licensure in accordance with the  
65 requirements of R.S. 37:694, and who was duly licensed as a professional  
66 engineer by the board.

1 G. The provisions of Subsections B, C and D shall not apply to any applicant  
2 who received a dishonorable discharge or to a military spouse whose spouse  
3 received a dishonorable discharge.

4 H. In Subsections B, C and D, the term *military* shall mean the armed forces  
5 or reserves of the United States, including the Army, Navy, Marine Corps, Coast  
6 Guard, Air Force, and the reserve components thereof, the National Guard of  
7 any state, the military reserves of any state, or the naval militia of any state.

43 Engineering," or "Professional Land Surveyor";

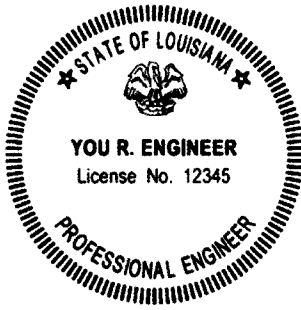

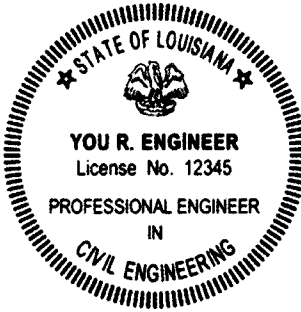

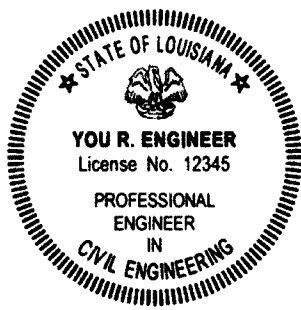

Mr. Landry presented the proposed revisions to Rule 2907 related to the standards of practice for boundary surveys. After discussion, the Board unanimously approved the motion made by Mr. Chustz, seconded by Dr. Gopu, to amend Rule 2907 as follows:

**§2907. Property Boundary Survey**

A. - F. ...

G. Plats and Maps. Every original plat or map of a property boundary survey should be a reproducible drawing at a suitable scale which clearly shows the results of the field work, computations, research and record information as

1 compiled and checked. The plat or map shall be prepared in conformity with  
2 the following guidelines.

3 G.1. – G.5. ...

4 6. A statement indicating the origin of azimuths or bearings shall be  
5 shown on each plat or map. If bearings are used, the basis of the bearing shall  
6 include one or more of the following:

7 G.6.a. ...

8 b. reference to the Louisiana state plane coordinate system with the  
9 appropriate zone and a controlling station(s) with coordinates and datum  
10 noted;

11 G.6.c. – H.11....

13 Mr. Landry discussed the proposed revisions to Rule 705 (relating to Board meetings),  
14 which were previously approved at the January 16, 2024 Board meeting, and Rule  
15 2911 (relating to references to the Department of Natural Resources), which were  
16 previously approved at the February 27, 2024 Board meeting. After discussion, the  
17 Board unanimously approved the motion made by Ms. Bergeron, seconded by Ms.  
18 Williams, to proceed with the promulgation process for these proposed revisions.




